- * Residential grass will only be accepted from (the per capita rate paying municipalities) which are Allen, Bushkill, Moore, East Allen, Lehigh, Northampton Borough, Catasauqua Borough, Lower Nazareth, Bath Borough and Whitehall, North Whitehall and South Whitehall Townships.
- * For 2024 residential grass users rate will be \$1.00 per **32 GALLON CONTAINER**.
- * **No BAGS OF ANY TYPE** will be permitted on the site (INCLUDING COMPOSTABLE).
- * FRCA will not accept Mixed loads (grass, leaves, brush commingled into one receptacle).
- * Grass will be accepted April 15th through October 1st.
- * Leaves will be accepted October 1st through December 17th.
- * FRCA defines grass as Turf Grass only. **No** ornamental grass of any type will be accepted at this site due to the inability to process this material and invasive nature of the seed pods.
- * Grass will only be taken while the site has capacity therefore all customers are reminded to have an alternate plan available for management of their grass.
- * Brush or logs over 12" in diameter, stumps, bamboo, hay, straw or sod is **NO LONGER ACCEPTED**.
